**7. GENERAL MATCH CONDITIONS**

Ref.	Subject	Match Condition
1a	Governance	These Melbourne Winter Baseball League (MWBL) Match Conditions are made as Regulations in accordance with the MWBL constitution.
1b	Governance	A recommendation for amendment to these MWBL Match Conditions must be supported by the majority of MWBL Clubs.  Note: The MWBL Pennant Committee reserve the right to amend these MWBL Match Conditions in accordance with any Victoria State Government health advice.
2a	Definitions	“League” means the Melbourne Winter Baseball League Inc (MWBL).
2b	Definitions	“Board” means the MWBL League Board.
2c	Definitions	“Club” means an Incorporated Club responsible for the administration of baseball club in the MWBL.
2d	Definitions	“Grade” means a competition comprising of Regular Season and Finals between baseball clubs that are members of the League. For Juniors, this is inclusive of the age group as defined by the league age of the participants.
2e	Definitions	“Pennant Committee” means the MWBL Pennant Committee (MWBLPC) whose Chair is voted in at the Annual General Meeting (AGM) and is responsible for the development of the MWBL Match Conditions.
2f	Definitions	“Seniors” means any open age grades.
2g	Definitions	“Women’s” means any open age Women’s grades.
2h	Definitions	“Juniors” means any junior grades or any player under 18 years of age.
3a	General	Except where otherwise stated in these Match Conditions, the Official Baseball Rules (OBR) are to be apply to all MWBL Competitions.
4a	Code of Conduct	<p><b>Players and Officials:</b></p> <p>This Code shall be read in conjunction with the Statement of Purposes and Rules, By-Laws and Match Conditions, and shall be binding on all Members of the MWBL. For the purpose of the Code “Players and Officials” means any person who is a registered member of a Club in this in this League;</p> <ul style="list-style-type: none"> <li>• a Coach,</li> <li>• a Scorer,</li> <li>• a Team Manager,</li> <li>• an Umpire, or</li> <li>• any person who acts in any official capacity within a Club in this League.</li> </ul> <p>Players and Officials are required to:</p> <ul style="list-style-type: none"> <li>• Abide by the “Code of Conduct” and all other rules of the MWBL, and to accept all disciplinary measures, including suspension, imposed for any breach of the Code and Rules;</li> <li>• Refrain from assaulting or attempting to assault an umpire, other players, any officials of the games or spectators;</li> <li>• Refrain from verbal abuse against umpires, scorers, opposing players or spectators;</li> <li>• Refrain from using crude or abusive language, or using crude or abusive hand signals, or engage in conduct detrimental to the game;</li> <li>• Refrain from reacting with unnecessary obvious dissension, displeasure or disapproval either toward an umpire, their decision, or following an umpiring decision;</li> <li>• Neither take nor use drugs or stimulants nor participate in other doping practices prohibited by the Australian Sports Commission and Baseball Australia;</li> <li>• Co-operate with all team members;</li> <li>• Show respect for opponents and their skills, be friendly to all participants;</li> <li>• Refrain from profanity at all times;</li> <li>• Refrain from any activity likely to result in loss or wilful damage to private property or to cause a disturbance;</li> <li>• Accept victory and defeat with dignity and grace;</li> <li>• Refrain from equipment abuse such as throwing helmets and bats; and</li> <li>• Abide by the rules and spirit of baseball.</li> </ul>

4b	Code of Conduct	<p><b>Scorers:</b></p> <p>The Council of Australian Baseball Scorers (CABS) Code of Conduct has been developed for all scorers to abide by whilst participating in an official capacity at any baseball game. It is recognised that scorers play an integral role in our sport and their performance and professionalism is observed by all in the baseball community in their capacity as a scorer.</p> <p>CABS Scorers acknowledge responsibility and agree to:</p> <ul style="list-style-type: none"> <li>• Accept responsibility for all their actions/decisions;</li> <li>• Sit with the opposition scorer in a neutral scoring location;</li> <li>• Remain in the designated scoring location until all post-game duties have been completed;</li> <li>• Be impartial on scoring deliberations;</li> <li>• Ensure scoring deliberations are made solely by the appointed scoring panel;</li> <li>• Declare a conflict of interest as necessary;</li> <li>• Keep abreast of rules and changing techniques of scoring;</li> <li>• Be respectful and open to discussion; and</li> <li>• Share scoring expertise and knowledge with other scorers and be a good role model for other officials.</li> </ul> <p>In the role as a scorer, the scorer shall not:</p> <ul style="list-style-type: none"> <li>• Be guilty of barracking whilst scoring;</li> <li>• Be guilty of making criticism of other scorers, umpires, coaches or team players by word or gesture;</li> <li>• Draw players or coaches attention to rule infringements, during the progress of the game;</li> <li>• Prompt the umpire about a ruling or status of pitch count unless invited;</li> <li>• Change a recorded scoring decision without regard for the recognised official procedure for the instance;</li> <li>• Use mobile telephone whilst scoring;</li> <li>• Smoke or drink alcohol whilst scoring;</li> <li>• Make comment to the media unless authorised by the appropriate personnel; and</li> <li>• Discretion should be used prior to releasing information during a game to a non-team or tournament Official.</li> </ul> <p><b>Note:</b> Unofficial visitors are not to be encouraged to remain in the score box / game scoring area</p>
4c	Code of Conduct	<p><b>Anti-Discrimination:</b></p> <p>Under Victoria's Equal Opportunity Act 2010, anti-discrimination laws also apply to all Sporting Organisations. Members are reminded that it is unlawful to discriminate or vilify against a person on the basis of:</p> <ul style="list-style-type: none"> <li>• Age,</li> <li>• Disability,</li> <li>• Industrial activity,</li> <li>• Lawful sexual activity / sexual orientation,</li> <li>• Marital, parental or carer status,</li> <li>• Physical features,</li> <li>• Political beliefs or activity,</li> <li>• Pregnancy,</li> <li>• Race,</li> <li>• Religious belief or activity, or</li> <li>• Personal association with a person who is identified by reference to any of the above attributes.</li> </ul> <p><b>Any violation of the Act will be dealt with in accordance with the rules of the MWBL &amp; Baseball Australia, and those of the Equal Opportunity Commission.</b></p>

The MWBL is an independently run sporting organisation, therefore all member clubs are required to abide by the Constitution, By-Laws, Rules and Match Conditions as presented by the MWBL.</p>
4d	Code of Conduct	<p><b>Behaviour of Players, Coaches, Officials and Spectators:</b>            Players and Officials are required to: Abide by the MWBL ‘Code of Conduct’ and all other Rules, By-Laws and Statement of Purposes and Match Conditions that shall be binding on all members of the Melbourne Winter Baseball League Inc. For information, please refer to MWBL Code of Conduct – Players and Officials (Match Condition 4a) for details.</p> <p><b>IN PARTICULAR:</b> Good relationships must be fostered between clubs and their teams before, during and particularly after games. The authority and decisions of the Umpire must be respected. Abuse and intimidating language and tactics must not be directed to any Umpire by any person.</p> <p>The Coach of each team must insist that their players behave in a sportsmanlike manner, especially towards members of the opposing team, at all times. The use of intemperate or unseemly language by players or coaches is absolutely forbidden. Spectators should not only support their own team, but show appreciation of good play by the opposition, and never barrack against or belittle their opponents.</p> <p>Club representatives of each team, including coaches and managers, are required to draw the attention of their spectators or own players to the above conditions, regarding behaviour, if these conditions are being disregarded.</p>
4e	Code of Conduct	<p><b>Prohibited Substances:</b>            No smoking/vaping, consuming an alcoholic beverage or chewing/dipping of tobacco will be allowed on the playing field or benches, offenders will be ejected from the game without warning and the club fined \$50 for each offence. Umpires shall enter each offence on match sheet.</p> <p>For the purpose of this Match Condition, a game is deemed to commence when the umpire enters the playing field in compliance with Official Baseball Rule 4.03(e). Any player, coach or official who, at or from that time, indulges in any of the activities mentioned in this Match Condition will be reported for breach of this Match Condition.</p>
5a	Baseballs	<p>The Home team is to provide match balls and have sufficient reserve balls in match condition to enable the game to continue without undue delay. The umpire(s) shall be the sole judge of fitness of any ball for play.</p> <p>The Home team is to provide balls meeting the following requirements:</p> <ul style="list-style-type: none"> <li>• Approved Winter Baseball;</li> <li>• Of the same make;</li> <li>• Leather; and</li> <li>• Waterproof.</li> </ul> <p>For A, B, and C Grade, a min. of two (2) new balls are to be provided at the start of the game.</p> <p>For all other Grades, a min. of one (1) new and one (1) in good condition balls are to be provided at the start of the game.</p> <p><b>NOTE:</b> If ground conditions allow, non-waterproof baseballs may be used BUT both teams are to agree to the ball change prior to the game and not at the plate meeting. If one team does not agree to the ball change, then waterproof baseballs are to be used as per the above.</p>
5b	Baseballs	<p>For finals, a min. of two (2) new balls are to be provided at the start of the game from each team. If teams supply different brands, then the clubs to agree on brand to be used. If teams cannot agree then the home team brand will be used. Teams to have a sufficient stock of balls on hand to complete the game in case of balls lost or damaged.</p>

6a	Game Start	<p><b>Game Times:</b> Games shall commence at times stated in the fixture or these Match Conditions, as relevant, subject to the Umpire being satisfied that the playing field is fit for the playing of the match in accordance with Match Condition 8a.</p>
6b	Game Start	<p><b>Unable to field a starting 9:</b> All teams require a minimum of seven (7) players to start the game. A team with less than seven players in attendance at a game start time may claim a ten (10) minute period for additional players to arrive. Play will commence as soon as both teams have seven or more players present. No extra time will be added to the scheduled finishing time. A team with less than seven players, ten (10) minutes after schedule starting time will forfeit the game and be fined \$50, plus the full umpiring fees for the match when officially appointed umpires are present.</p>
6c	Game Start	<p><b>Line-Ups:</b> A blank is where anyone of the nine (9) positions in the batting line-up are not filled by a player. Blanks will only constitute an out in A, A Res, B, B Res and C Grades.  Where a team starts with nine (9) (or more players) in the batting line-up, Match Condition 15a will be in effect.</p>
6d	Game Start	<p><b>Courtesy Fielders:</b> A and B Grade teams must start with nine (9) players. If an A or B Grade team has only seven (7) or eight (8) players at the start of the game, then a player can be used as a substitute fielder (i.e. substitute fielder but does not bat) until the completion of the second innings when a re-entry player/s can be used. Penalty for teams giving the walkover prior to game day: Senior Team - \$50 fine and no match points. Junior Team - \$30 fine and no match points.  Clubs that do not forfeit the lowest grade team will be fined as above and also two (2) match points will be deducted from all teams below the grade that forfeited.  Walkovers will be scrutinized by the Pennant Committee and clubs found to not have followed protocol may have a further penalty applied at the discretion of the Pennant Committee</p>
7c	Forfeits and Walkovers	<p><b>At the ground on game day:</b> The team giving a walkover must report on the match card the names of the players in attendance. The team receiving the forfeit must record on the card not less than seven (7) players. Players named on the match card are ineligible to play in another match of the same round.  Penalty for teams giving the walkover on game day: Senior Team - \$50 fine and no match points plus appointed umpire's fees (if attended). Junior Team - \$30 fine and no match points plus appointed umpire's fees (if attended).</p>

8a	Grounds Conditions	<p>The order of authority for determining the fitness to play of any ground is as follows:</p> <ol style="list-style-type: none"> <li>1. The Home Club Grounds Manager or representative will be the sole judge of fitness to play at their ground prior to the arrival of an MWBL appointed Umpire;</li> <li>2. For Junior Area Centres, then the centre manager shall be the sole judge of whether or not games will start or not start at all, in the event of adverse or wet weather conditions;</li> <li>3. Upon arrival, MWBL appointed umpire(s) will be the sole judge of the fitness to play of any ground. The Senior umpire will have the final decision.</li> <li>4. If at club grounds with no MWBL appointed umpire, then the two coaches to get together and judge the game start time or not at all in the event of adverse weather. If the coaches cannot agree then the Club appointed Umpire will be the sole judge.</li> </ol> <p>A team shall be allowed not more than fifteen (15) minutes from scheduled starting time to prepare the ground and ground markings before the Umpire will decide on the fitness to play on the ground.</p> <p>Once the umpires have informed both clubs of their decision, this decision will be final.</p> <p><b>NOTE 1:</b> Appointed umpires to remain in attendance for adjudication for the late game if the early game of a double header is not played due to unplayable ground conditions.</p> <p><b>NOTE 2:</b> No scheduled match shall be relocated or scheduled for an alternate time without the prior approval of the MWBL Pennant Committee Chairperson or nominee.</p>
8b	Grounds Conditions	<p><b>Approved Lights:</b></p> <p>Clubs with Baseball Victoria approved lights are permitted to use artificial lighting during games to supplement natural light due to dark conditions. Artificial Lights are to be approved by Baseball Victoria prior to use for scheduled night games as fixtured. The following venues are approved for use of lights:</p> <ul style="list-style-type: none"> <li>• Arthur Field at Surrey Park, Melbourne</li> <li>• Bicentennial Park, Bonbeach</li> <li>• Ganbu Djila Sports Park, La Trobe University / Preston</li> <li>• Geelong Baseball Centre, Geelong</li> <li>• Gilbert Park, Knox</li> <li>• Kings Park, Upwey Ferntree Gully</li> <li>• Longstaff Field at JL Murphy Reserve, Port Melbourne</li> <li>• Melbourne Ballpark, Altona</li> <li>• Prince of Wales Recreational Reserve, Ballarat</li> <li>• Robert Booth Reserve, Dandenong / Mulgrave</li> </ul>
8c	Ground Conditions	<p><b>Washouts:</b></p> <p>Where games are abandoned due to adverse wet weather or unsuitable ground conditions, etc, the following procedure is to be followed:</p> <ol style="list-style-type: none"> <li>1. Where games do not commence then the match card is to be completed to reflect abandoned game and to be signed by both clubs and umpires and forwarded to the MWBL Administrator.</li> <li>2. Clubs may enter a minimum of seven (7) players names on the match card, that have played previously with the club in that season prior to the washout or any new player registrations (as per the "Registrations of Players" By-Law). Players names that appear on the match card that have not played previously will be an illegal player and the penalty will be \$50 per player and the loss of one (1) match point.</li> <li>3. If the washout, etc, occurs in round 1 – then clubs are permitted to use names of currently registered players or new registrations.</li> <li>4. 9a	Grounds and Equipment	<p><b>Grounds:</b> It is required that back nets must be provided for all games.</p> <p>Pitching mats may be used in all games. All mounds must have a regulation approved pitching plate affixed to the mound, with a rubber (or similar material) strip in the front of the pitching plate, minimum 400mm in length &amp; minimum width of the pitching plate.</p> <p>All bases, pitcher's plate and home plate must be whitened at start of game or be of an acceptable standard. For Seniors and Women's games, the bases and pitching plate must be pegged. For Juniors games, the bases must be sliding bases. The home plate must not be fixed or pegged unless flush with the surface. The home team is to supply ALL bases and other field equipment unless other arrangements have been made. PENALTY: Fine of \$10 for each item unpegged per game.</p> <p>The Plate Umpire will be the sole judges of fitness and marking of grounds.</p>
9b	Grounds and Equipment	<p><b>Dugouts:</b> Clubs are required to provide bench areas for both the home and away teams of a similar standard. All benches are to have protection screens in front – either permanent or temporary to protect the players from stray balls.</p> <p>Failure to do so will result in an appearance before the MWBL Executive and a penalty may be applied by the MWBL Executive. Failure to comply will result in loss of two (2) match points for first offence and after second offence games will not be scheduled at that ground until protection is provided to the satisfaction of the MWBL Pennant Committee.</p>
9c	Grounds and Equipment	<p><b>Home Run Fence and Marshals:</b> On open grounds, home run markers must be supplied. A white line must be drawn between each foul line to define the home run fence. It is encouraged that home run marshals be provided by each competing team, otherwise the "HONESTY SYSTEM" of outfielders will prevail.</p> <p>For Finals games on open grounds, one (1) boundary rider to be supplied by each competing club, and in position when managers meet with umpires. Umpires will not start game until boundary riders are in position. If a boundary rider leaves their position whilst game is in progress, umpires will suspend play for a maximum of five (5) minutes. If play cannot resume, the defaulting club will forfeit game.</p>
9d	Grounds and Equipment	<p><b>Out of Play:</b> For consistency throughout the league, boundaries defined by witches' hats, metal uprights or the like will be regarded as out of play. Any ball rebounding from such an object will be declared DEAD. Batters and runners will advance, in accordance with the Official Rules of Baseball.</p>
9e	Grounds and Equipment	<p><b>Catch and Carry:</b> To clarify the legality of catches made next to the Dead Ball Line (DBL), on open grounds the following interpretation is to be used.</p> <ul style="list-style-type: none"> <li>For a catch to be legal, no part of the fielder's body can be grounded outside of the DBL. If part of the fielder's body over the DBL is in the air at the time of the catch, the catch is still legal.</li> <li>If the catch is taken in Live Ball Territory (LBT) and the fielder's momentum carries him over the DBL line, the catch is legal, the ball is dead, and any base runners will advance one base. If a fielder's momentum carries him into DBT there can be no spectator interference. The fielder enters the DBT at their own risk.</li> </ul>
10a	Protective Equipment – Helmets	<p>All batters and runners <b>MUST</b> wear double-eared helmets with appropriate padding. Any player refusing to do so will be declared out. Any runner deliberately discarding or carrying a helmet will be declared out.</p>
10b	Protective Equipment – Helmets	<p>The Umpire(s) has the right to inspect any helmet for safety, and not permit the use of any helmet which, in their opinion, is unsafe.</p> <p>Should a batter appear at the plate without a helmet, the Umpire shall call TIME and instruct the defaulting player to obtain a helmet before they will be allowed to take their time at bat.</p>
10c	Protective Equipment – Helmets	<p>Base coaches in <b>ALL</b> MWBL games at all levels of baseball must wear a helmet at all times. Helmets can be skull caps. Junior players are to wear double-eared helmets if they are base coaching in any MWBL game. Junior players must have attained the age of 14 years old to base coach in a Seniors or Women's game.</p>

It is compulsory for junior catchers to wear helmet, mask, throat guard, chest plate and leggings when catching.</p> <p><b>All players warming up pitchers MUST wear masks.</b></p> <p>Catcher’s helmets, masks or full mask/helmet combination is to be used. Catchers, coaches, parents and other junior players will wear catcher’s helmet, mask, and throat guard when warming up pitchers. Senior players participating in a Seniors game must wear catcher’s mask as a minimum standard when warming up pitcher.</p>
13a	Collisions at the Plate	<p>A runner attempting to score may not deviate from their direct pathway to the plate in order to initiate contact with the Catcher (or other player covering home plate). If, in the judgment of the Umpire, a runner attempting to score initiates contact with the catcher (or other player covering home plate) in such a manner, the Umpire shall declare the runner out (even if the player covering home plate loses possession of the ball). In such circumstances, the Umpire shall call the ball dead and all other base runners shall return to the last base touched at the time of the collision.</p> <p>Please refer to OBR 7.13 for further details.</p>
14a	Pre-Match Warm-Up	<p><b>Seniors and Women’s:</b> Twenty (20) minutes prior to the scheduled start time, the home team may use the diamond for a maximum of seven (7) minutes.</p> <p>Twelve (12) minutes prior to the scheduled start time, the away team may use the diamond for a maximum of seven (7) minutes.</p> <p>Team managers by mutual agreement can reverse order of team’s pre-game warm up. Five (5) minutes prior to the scheduled start time, the diamond is to be vacated. Coaches from both teams are to meet with the Umpires at home plate to determine ground rules, match conditions and to exchange team line-ups.</p>
14b	Pre-Match Warm-Up	<p><b>Juniors:</b> Fifteen (15) minutes prior to the scheduled start time, the home team may use the diamond for a maximum of five (5) minutes.</p> <p>Ten (10) minutes prior to the scheduled start time, the away team may use the diamond for a maximum of five (5) minutes.</p> <p>Team managers by mutual agreement can reverse order of team’s pre-game warm up. Five (5) minutes prior to the scheduled start time, the diamond is to be vacated. Coaches from both teams are to meet with the Umpires at home plate to determine ground rules, match conditions and to exchange team line-ups.</p>
15a	Extended Line-Up	<p>An extended batting line-up (15 players maximum) may be used in all Seniors and Women’s Grades except for A, A Res, B, B Res and C Grade.</p> <p>Any team wishing to use the extended line-up must indicate their intention to do so prior to the start of the game, with the umpire(s) and opposition manager in attendance. It is not compulsory for both teams to use this rule.</p> <p>If a team has invoked the extended line up rule, players nominated on the extended line up can change fielding positions at any time during the game. There are no requirements for a player to play in the field at any time during the game.</p> <p>Bench players who have not participated in the game may take the place of an injured or removed player. If teams do not use the extended line-up, then they are bound by the traditional removal of players and bench players coming into the game.</p>

15b	Extended Line-Up	<p><b>Line-Up Compression (Not allowed in A3, A4, B3, B4 and C Res Grade)</b> If a player on the extended batting line up does not take their turn at bat for any reason, then that batter is deemed to have been removed from the game and is then removed from the batting line up. The player can no longer participate in the game, and a blank will be declared which will result in an automatic out for the fielding team, i.e. batting line up is not to be compressed.</p> <p><b>Line-Up Compression (All Other Grades except Juniors)</b> If a player on the extended batting line up does not take their turn at bat for any reason, then that batter is deemed to have been removed from the game and is then removed from the batting line up. The player can no longer participate in the game, and the line-up is compressed (no blanks) with all subsequent batters batting in order skipping the removed player.</p> <p>NOTE: A team can only compress an extended line-up back to nine (9) batters. Any additional players removed from the line-up (compression to seven (7) or eight (8) batters in the line-up) will result in a blank (and automatic out) in place of the removed players.</p>
16a	Five-Minute Rule	<p>If five minutes or less remains at the completion of even innings, the match shall end.</p> <p><b>Note:</b> If, at five minutes before the scheduled time of completion, the home team is at bat and is ahead, the match shall end.</p> <p>The five-minute rule shall apply to all Seniors and Women’s MWBL games, except for A and B Grade Finals.</p>
16b	Five-Minute Rule	<p><b>Early Games:</b> The five-minute rule shall apply to all early games where two (2) or more Seniors or Women’s games are scheduled at the same ground on the same day with the following variation.</p> <p>If the five-minute rule applies a maximum of ten (10) minutes from the scheduled finish time will be allowed for the completion of the innings which commenced as per criteria listed above. At 2.25pm (ten (10) minutes after the scheduled finish time, if there is no result (teams tied) or the innings has not been completed, the match will cease (end of game) and the scores revert back to the last even Innings prior to the five-minute rule commencing (unless the home team has tied the game at 2.25pm).</p> <p><b>NOTE:</b> Time is not to be added on to the length of games due to wet weather interruptions, unsafe ground conditions, etc. Games tied at the game time end (after equal innings) shall be recorded as a tied game.</p>
16c	Five-Minute Rule	<p><b>Late or Single Games:</b> All late games and single games with a scheduled finish time shall be subject to the ‘Five-Minute Rule’ as listed in Match Condition 16a. There shall be no time limit to complete any inning started before the five-minute rule is in effect.</p>
17a	Determination of Results in Time Games	<p>In regard to final scores in TIME games, various examples are given below.</p> <p><b>Definition:</b> An innings refers to when each team has had a time at bat. The basic principle to keep in mind is, When an UNEQUAL number of innings has been played, the score reverts back to the last completed number of equal innings except where:</p> <ol style="list-style-type: none"> <li>The home team (batting second) is ahead.</li> <li>The home team (batting second), having scored an equal number to, or less runs than the away team (batting first) by the end of the last completed number of innings, has in the incomplete inning, scored sufficient runs to make the score a TIE.</li> </ol> <p>In each of the following examples, “A” is the away team (batting first), and “B” the home team (batting second).</p>

All other grades must have a minimum seven (7) players in approved uniform. Caps when worn MUST be approved club cap. Fine of \$10 for each player wearing an incorrect uniform.</p> <p><b>Advertising on Uniforms:</b></p> <ol style="list-style-type: none"> <li>a. Selective advertising is permissible on the back or sleeve of Seniors, Women's and Juniors uniforms.</li> <li>b. All such advertising must be approved by the MWBL. Clubs are cautioned that cigarette, liquor and hotel advertising will not be permitted.</li> </ol>
22a	Blood and Concussion	<p><b>Blood Rule:</b></p> <ol style="list-style-type: none"> <li>1. A player for any reason suspected of having sustained concussion during a game is to be removed immediately from the game in accordance with the Baseball Victoria Concussion Policy. The umpire is to be informed that the player is being removed due to concussion and the player's name and the time that the player is directed to leave the playing field shall be marked in the scorebook.</li> <li>2. 23a	Jewellery	<p>Exposed jewellery such as wrist watches, bracelets and types of earrings, neck chains, or any other items judged as dangerous by the umpire may not be worn during the game. Players must be asked to remove jewellery and if they fail to do so will be ejected from the game.</p>
24a	Footwear	<p>Metal cleats must <b>NOT</b> be worn by any junior player in junior games. Umpires can inspect shoes at the start of the game. If a player is found to be wearing metal cleats during the game, then the player is to be ejected from the game and issued a \$25 fine. Only moulded rubber/plastic stops, plastic cleats, sandshoes, gym boots, sneakers are permitted. Plastic stops are permitted as long as there is no metal protruding through the plastic stops.</p> <p><b>NOTE:</b> Junior players can wear metal cleats in Seniors or Women’s games.</p>
25a	Umpires	<p><b>Game Day:</b> Where no league appointed umpire is present at the game, the Home Club shall appoint an “Plate Umpire” to call balls and strikes. The Visiting team should supply a “Base Umpire”. Club Umpires shall have the same authority as an MWBL appointed umpire. If the home team is not able to supply an “Plate Umpire” then the away side is permitted to. It is desirable that the “Plate Umpire” call from behind the catcher, however it is also practical to call balls and strikes from behind the pitching mound. 25b	Umpires	<p><b>Helmets:</b> It is recommended that all umpires (including MWBL appointed and club umpires) when umpiring as a single umpire from behind the pitching mound wear a skull cap type helmet. Normal line umpires are not required to wear skull helmets.</p>
25c	Umpires	<p><b>Change Rooms:</b> Clubs are to provide appropriately clean and clear of equipment separate private area for umpires to be able to change into their gear and clothing without being exposed to the general public. If the change area is within the general pavilion area, then appropriate screening (temporary or permanent) are required to be provided. Failure to comply with this requirement may result in the club being brought before the MWBL Pennant Committee, fine applied and non-appointment of umpires to games at that ground.</p>
26a	Disputes and Protests	<p>In the event of any dispute or protest (other than a judgement decision, which may not be disputed) the protest must be lodged at the time of the objection with the umpire who must be given the opportunity to consider the point raised by the manager. Should the Manager decide to continue the protest, the umpire shall be advised and before play continues the scorers must endorse both score books, ensuring the following details are marked:</p> <ul style="list-style-type: none"> <li>(i) Position of runners on base;</li> <li>(ii) Time of day;</li> <li>(iii) Ball and strike count on batter;</li> <li>(iv) Score at time of protest; and</li> <li>(v) Number of outs</li> </ul> <p>The Manager of the protesting team shall, at the conclusion of the match, advise the umpire whether the protest is to be proceeded with. It is then the responsibility of the protesting Manager to request the umpires to endorse upon the Match Report Card that a protest has been lodged.</p> <p>Notice of the protest must be lodged in writing, be delivered to the Administrator within forty-eight (48) hours of completion of the game and be accompanied by a one-hundred-dollar (\$100) fee, which shall be returned if the Pennant Committee does not consider the protest frivolous. The notice of protest shall include reference to the Official Baseball Rule being protested and full reasons why the protest is being entered.</p>

28c	Reported Persons	<p><b>Alternative Penalty:</b> Players and coaches that are reported and accept a penalty offer from the Report Review Person or found guilty of an offence at the tribunal may be offered the option of an alternate penalty by umpiring games instead of serving the full penalty.</p> <p>The Pennant Committee will be the responsible body for offering the alternate penalty option of umpiring. 30a	Melees	<p>If team/s are found by the league to have been involved in a melee, prior, during or after a game, then the club/s involved will be fined \$500 (not a bond) and if any second offence by the club in any grade, then that team (players listed on the match sheet) will be suspended for at least one (1) game. Player(s) involved in the melee can still be reported by the umpire/s for any other offence and face possible discipline by the league tribunal.</p>

In the event of no MWBL appointed umpires, the HOME TEAM is to email scores during the Finals Series.</p> <p><b>Match Report Sheet:</b> Match Report Sheets can be sent to the MWBL Administrator by email within seventy-two (72) hours after the day of the game. 34a	Senior Games	<p><b>Game Length:</b> All grades – two (2) hours or nine (9) innings with the five-minute rule (Match Condition 15ba) and Mercy Rule (Match Condition 34e) in effect. If time permits extra innings can be played in accordance with Match Condition 34d.</p>
34b	Senior Games	<p><b>Game Times:</b> Game Times will be published with the MWBL Fixtures. Should competing clubs wish to change a game start time, both clubs must submit, in writing, an application to the MWBL Administrator with the request to be reviewed by the MWBL Pennant Committee. Any requests must be made at least seven (7) days in advance of the game.</p> <p><b>Early Games and Single Games:</b> 12:15pm, unless otherwise stated.</p> <p><b>Late Game:</b> 2:40pm or scheduled to start time twenty-five (25) minutes after early game has finished but not before the scheduled start time unless agreed to by both managers and umpires. For night games if there is any stoppage due to bad weather, two (2) hours after scheduled starting time, the game is to be stopped and scores will revert back to equal innings.</p> <p><b>Single and Late Games:</b> The game will not start unless there is sixty-five (65) minutes playing time left, the five-minute rule may apply after sixty-five (65) minutes, but any stoppage during the sixty-five (65) minutes and the five-minute rule will not apply.</p> <p><b>Night Games:</b> For night games, if there is any stoppage due to bad weather two (2) hours after scheduled starting time the game is to be stopped and scores will revert back to equal innings.</p>
34d	Senior Games	<p><b>Extra Innings:</b> If time permits at the completion of the scheduled nine (9) innings, and the game remains tied, extra innings can be played. International Tiebreaker rules will be in effect.</p> <p>Each team is to start each extra inning with the last two batters from the previous innings, where the last batter is placed on 1<sup>st</sup> base and the second last batter is placed on 2<sup>nd</sup> base. Example: If Batter #5 is due to lead off the extra inning, then Batter #4 will be placed at 1<sup>st</sup> base and Batter #3 will be placed at 2<sup>nd</sup> base. Any player deemed to be a Non-National player will be allowed to only pitch in every second game for that clubs scheduled games during the Regular Season. This is applicable to all grades.</p> <p><b>For the Finals Series the following shall apply.</b> A non-national player may only pitch a maximum of five (5) innings for each finals game over the final's series. A player will be deemed 'non-national' if they are not an Australian Citizen or Permanent Resident or have not continuously resided in Australia for a period of twelve (12) calendar months immediately prior to the commencement of the season in which a Club wishes to register them as a player. A 'non-national' player that is studying at an approved University or Tafe course and on an appropriate visa will not be subject to the 'non-national' rule.</p> <p>c. A player on Temporary Activity VISA 408 (Sporting Activities), will be considered as a Non-National regardless of the length of time they have been in Australia.</p> <p>d. The Melbourne Winter Baseball League accepts no responsibility for fulfilling of any obligations or requirements for entry of a non-national player into Australia, or any obligations or requirements noted within any contractual agreements between a Club and a non-national player.</p> <p>e. A Club may only register and play one (1) non-national player in their senior firsts team for any season.</p> <p>f. There is no restriction on the number of non-national players a Club may register and play in any other team for the season of registration.</p> <p>g. A Club wishing to register non-national players for a season must identify the non-national players at the time of registration and nominate the non-national player that is to play in the firsts senior team, for the season of registration at the time of registration.</p> <p>h. The non-national nomination must be received and approved by the Pennant Committee prior to the player being able to participate in the Melbourne Winter Baseball League competition.</p> <p>i. A Club may request approval from the Pennant Committee to change the non-national player nominated to play in the firsts senior team for the season of registration due to injury or other extenuating circumstances.</p> <p>j. The Pennant Committee or the Administrator of the Melbourne Winter Baseball League may seek evidence on any player it deems to be a non-national that has not been declared by their Club. The Pennant Committee or the Administrator of the Melbourne Winter Baseball League may determine the form of this evidence at the time of the request.</p> <p>k.
