GENERAL MATCH CONDITIONS

Ref.	Match Condition
1. GOVERNANCE	
1(a)	These Melbourne Winter Baseball League (MWBL) Match Conditions are made as Regulations in accordance with the MWBL constitution.
1(b)	A recommendation for amendment to these MWBL Match Conditions must be supported by the majority of MWBL Clubs. NOTE: The MWBL Pennant Committee reserve the right to amend these MWBL Match Conditions in accordance with any Victoria State Government health advice.
2. DEFINITIONS	
2(a)	“League” means the Melbourne Winter Baseball League Inc (MWBL).
2(b)	“Board” means the MWBL League Board.
2(c)	“Club” means an Incorporated Club responsible for the administration of baseball club in the MWBL.
2(d)	“Grade” means a competition comprising of Regular Season and Finals between baseball clubs that are members of the League. For Juniors, this is inclusive of the age group as defined by the league age of the participants.
2(e)	“Pennant Committee” means the MWBL Pennant Committee (MWBLPC) whose Chair is voted in at the Annual General Meeting (AGM) and is responsible for the development of the MWBL Match Conditions.
2(f)	“Seniors” means any open age Grades for any players aged 14 years and above.
2(g)	“Women’s” means any open age Women’s Grades for female players aged 13 years and above.
2(h)	“Juniors” means any Junior Grades or any player under 18 years of age.
3. GENERAL	
3(a)	Except where otherwise stated in these Match Conditions, the Official Baseball Rules (OBR) are to be apply to all MWBL Competitions.
4. MEMBERSHIP AND CODE OF CONDUCT	
4(a)	Registration: All MWBL Members must be registered in accordance with the MWBL By-Laws (By-Law 15).
4(b)	Clearances: Clearances for MWBL clubs and members close on the 30th of June each season for players registered within Victoria in the MWBL and/or other competing Winter baseball leagues/Associations. Please refer to the MWBL By-Laws (By-Law 16 and By-Law 17) for details around clearance procedures.
4(c)	Code of Conduct: All members of the MWBL, players, officials, scorers and spectators are required to follow the Codes of Conduct found in the MWBL Statement of Purpose and Rules (Part D – Code of Conduct). This includes abiding by the anti-discrimination policy (Part E – Antidiscrimination) and the behavioural expectations.
4(d)	Prohibited Substances: No smoking/vaping, consuming an alcoholic beverage or chewing/dipping of tobacco will be allowed on the playing field or benches, offenders will be ejected from the game without warning and the club fined \$50 for each offence. Umpires shall enter each offence on match sheet. For the purpose of this Match Condition, a game is deemed to commence when the umpire enters the playing field in compliance with Official Baseball Rule 4.03(e). Any player, coach or official who, at or from that time, indulges in any of the activities mentioned in this Match Condition will be reported for breach of this Match Condition.
4(e)	Melees: If team/s are found by the league to have been involved in a melee, prior, during or after a game, then the club/s involved will be fined \$500 (not a bond) and if any second offence by the club in any grade, then that team (players listed on the match sheet) will be suspended for at least one (1) game. Player(s) involved in the melee can still be reported by the umpire/s for any other offence and face possible discipline by the league tribunal.

4(f)	<p>Reported Persons:</p> <p>All reported persons shall be subject to MWBL Reported Persons and Tribunal Procedure (By-Law 29). The MWBL adopts a zero tolerance policy with the power of umpires to provide either a Yellow Card and /or Blue Card. This includes officials and spectators, which the MWBL reserves the right to investigate reports on any member of the MWBL and take such action as it deems necessary. The MWBL administrator shall be informed in writing, including the reasons to justify the report, so the report can be investigated by the MWBL.</p>
5. BASEBALLS	
5(a)	<p>The Home team is to provide match balls and have sufficient reserve balls in match condition to enable the game to continue without undue delay. The umpire(s) shall be the sole judge of fitness of any ball for play. The Home team is to provide balls meeting the following requirements:</p> <ul style="list-style-type: none"> (i) Approved Winter Baseball; (ii) Of the same make; (iii) Leather; and (iv) Waterproof. <p>For A, B, and C Grade, a min. of two (2) new balls are to be provided at the start of the game.</p> <p>For all other Grades, a min. of one (1) new and one (1) in good condition balls are to be provided at the start of the game.</p> <p>NOTE: If ground conditions allow, non-waterproof baseballs may be used BUT both teams are to agree to the ball change prior to the game and not at the plate meeting. If one team does not agree to the ball change, then waterproof baseballs are to be used as per the above.</p>
5(b)	<p>For finals, a min. of two (2) new balls are to be provided at the start of the game from each team. If teams supply different brands, then the clubs to agree on brand to be used. If teams cannot agree then the home team brand will be used. Teams to have a sufficient stock of balls on hand to complete the game in case of balls lost or damaged.</p>
6. GAME START	
6(a)	<p>Game Times:</p> <p>Games shall commence at times stated in the fixture or these Match Conditions, as relevant, subject to the Umpire being satisfied that the playing field is fit for the playing of the match in accordance with Match Condition 8(a).</p>
6(b)	<p>Unable to Field a Starting Nine (9):</p> <p>All teams require a minimum of seven (7) players to start the game. A team with less than seven players in attendance at a game start time may claim a ten (10) minute period for additional players to arrive. Play will commence as soon as both teams have seven or more players present. No extra time will be added to the scheduled finishing time.</p> <p>A team with less than seven players, ten (10) minutes after schedule starting time will forfeit the game and be fined \$50, plus the full umpiring fees for the match when officially appointed umpires are present.</p>
6(c)	<p>Line-Ups – Blanks:</p> <p>A blank is where anyone of the nine (9) positions in the batting line-up are not filled by a player.</p> <p>A, A Res, B, B Res and C Grade: Blanks will be considered an automatic out.</p> <p>For all other grades: Blanks will not be an automatic out, however where a team starts with an extended line-up (more than nine (9) players), Match Condition 15(b) will be in effect for line-up compression.</p>
6(d)	<p>Courtesy Fielders:</p> <p>A and B Grade teams must start with nine (9) players. If an A or B Grade team has only seven (7) or eight (8) players at the start of the game, then a player can be used as a substitute fielder (i.e. substitute fielder but does not bat) until the completion of the second innings when a re-entry player/s can be used.</p> <p>If a team uses a substitute player as a fielder at the start of the game, then that player CANNOT be used as a re-entry player after the second innings and shall be immediately removed from the game and may not take any further part in the game except in a coaching capacity.</p>

7. FORFEITS AND WALKOVERS	
7(a)	<p>If either team has less than the required regulation team of seven (7) players in attendance at the scheduled starting time, the defaulting team will be given TEN (10) MINUTES grace in which to find the required number of players.</p> <p>If after ten (10) minutes a team is unable to find seven (7) players, the match will be forfeited to their opponent and a score of nil (0) runs to nine (9) will be recorded against them. The team winning by default will be credited with a score of nine (9) runs to nil (0).</p> <p>Should both teams be at fault the Umpire will declare a “NO GAME” and both teams will have a score of nil (0) runs to nine (9) debited against them. For forfeiting a match or conceding a walk-over a fine will be imposed, plus any other penalty the MWBL may decide.</p>
7(b)	<p>Prior to Game Day:</p> <p>Clubs giving a walkover prior to game day are required to forfeit the clubs lowest grade team and to notify the opposing club and the League Administrator as soon as possible. Clubs that do not forfeit the lowest grade team will be fined as below and also two (2) match points will be deducted from all teams below the grade that forfeited.</p> <p>Note: Clubs may apply to the MWBL Pennant Committee at least seven (7) days in advance to request the forfeiture of a higher ranked team, but this be accompanied with good reason, and be approved by the MWBL Pennant Committee. Higher ranked teams that forfeit may be subject to Match Condition 32(a) (Byes) or other limitations at the discretion of the MWBL Pennant Committee.</p> <p>Penalty for teams giving the walkover prior to game day:</p> <ul style="list-style-type: none"> (i) Senior Team - \$50 fine and no match points. (ii) Junior Team - \$30 fine and no match points. <p>Walkovers will be scrutinised by the Pennant Committee and clubs found to not have followed protocol may have a further penalty applied at the discretion of the Pennant Committee. This includes clubs that forfeit multiple times in the same season who may be subject to the disqualification of finals eligibility for individual team(s), if found to have forfeited without good reason.</p>
7(c)	<p>At the Ground on Game Day:</p> <p>The team giving a walkover must report on the match card the names of the players in attendance. The team receiving the forfeit must record on the card not less than seven (7) players. Players named on the match card are ineligible to play in another match of the same round.</p> <p>Penalty for teams giving the walkover on game day:</p> <ul style="list-style-type: none"> (i) Senior Team: \$50 fine and no match points plus appointed umpire’s fees (if attended). (ii) Junior Team: \$30 fine and no match points plus appointed umpire’s fees (if attended).
8. GROUND CONDITIONS	
8(a)	<p>The order of authority for determining the fitness to play of any ground is as follows:</p> <ul style="list-style-type: none"> (i) The Home Club Grounds Manager or representative will be the sole judge of fitness to play at their ground prior to the arrival of an MWBL appointed Umpire; (ii) For Junior Area Centres, then the centre manager shall be the sole judge of whether or not games will start or not start at all, in the event of adverse or wet weather conditions; (iii) Upon arrival, MWBL appointed umpire(s) will be the sole judge of the fitness to play of any ground. The Senior umpire will have the final decision. (iv) If at club grounds with no MWBL appointed umpire, then the two coaches to get together and judge the game start time or not at all in the event of adverse weather. If the coaches cannot agree then the Club appointed Umpire will be the sole judge. <p>A team shall be allowed not more than fifteen (15) minutes from scheduled starting time to prepare the ground and ground markings before the Umpire will decide on the fitness to play on the ground. Once the umpires have informed both clubs of their decision, this decision will be final.</p> <p>NOTE 1: Appointed umpires to remain in attendance for adjudication for the late game if the early game of a double header is not played due to unplayable ground conditions.</p> <p>NOTE 2: No scheduled match shall be relocated or scheduled for an alternate time without the prior approval of the MWBL Pennant Committee Chairperson or nominee.</p>

8(b)	<p>Approved Lights:</p> <p>Clubs with Baseball Victoria approved lights are permitted to use artificial lighting during games to supplement natural light due to dark conditions. Artificial Lights are to be approved by Baseball Victoria prior to use for scheduled night games as fixtured and grounds must be on Baseball Victoria’s approved list.</p>
8(c)	<p>Washouts:</p> <p>Where games are abandoned due to adverse wet weather or unsuitable ground conditions, etc, the following procedure is to be followed:</p> <ul style="list-style-type: none"> (i) Where games do not commence then the match card is to be completed to reflect abandoned game and to be signed by both clubs and umpires and forwarded to the MWBL Administrator. (ii) Clubs may enter a minimum of seven (7) players names on the match card, that have played previously with the club in that season prior to the washout or any new player registrations (as per the “Registrations of Players” By-Law). Players names that appear on the match card that have not played previously will be an illegal player and the penalty will be \$50 per player and the loss of one (1) match point. (iii) If the washout, etc, occurs in round 1 – then clubs are permitted to use names of currently registered players or new registrations. (iv) In the event that clubs call off games early and notify the away club to prevent unnecessary travel, then the away club are not required to sign the match card or enter names on the match card. (v) The away team may submit a separate match card to the league Administrator with a minimum of seven (7) eligible players’ names within seven (7) days after the abandoned game. (vi) For all grades, if at least one (1) match is completed, the round for that grade will be considered as played. (vii) Refer to Match Condition 8(a) for additional information around fitness of grounds.
9.	GROUNDS AND EQUIPMENT
9(a)	<p>Grounds:</p> <p>It is required that back nets must be provided for all games.</p> <p>Pitching mats may be used in all games. All mounds must have a regulation approved pitching plate affixed to the mound, with a rubber (or similar material) strip in the front of the pitching plate, minimum 400mm in length & minimum width of the pitching plate.</p> <p>All bases, pitcher’s plate and home plate must be whitened at start of game or be of an acceptable standard. For Seniors and Women’s games, the bases and pitching plate must be pegged. For Juniors games, the bases must be sliding bases. The home plate must not be fixed or pegged unless flush with the surface. The home team is to supply ALL bases and other field equipment unless other arrangements have been made.</p> <p>PENALTY: Fine of \$10 for each item unpegged per game.</p> <p>The Plate Umpire will be the sole judges of fitness and marking of grounds.</p>
9(b)	<p>Dugouts:</p> <p>Clubs are required to provide bench areas for both the home and away teams of a similar standard. All benches are to have protection screens in front – either permanent or temporary to protect the players from stray balls.</p> <p>Failure to do so will result in an appearance before the MWBL Executive and a penalty may be applied by the MWBL Executive. Failure to comply will result in loss of two (2) match points for first offence and after second offence games will not be scheduled at that ground until protection is provided to the satisfaction of the MWBL Pennant Committee.</p>
9(c)	<p>Home Run Fence and Marshals:</p> <p>On open grounds, home run markers must be supplied. A white line must be drawn between each foul line to define the home run fence. It is encouraged that home run marshals be provided by each competing team, otherwise the “HONESTY SYSTEM” of outfielders will prevail.</p> <p>For Finals games on open grounds, one (1) boundary rider to be supplied by each competing club, and in position when managers meet with umpires. Umpires will not start game until boundary riders are in position. If a boundary rider leaves their position whilst game is in progress, umpires will suspend play for a maximum of five (5) minutes. If play cannot resume, the defaulting club will forfeit game.</p>
9(d)	<p>Out of Play:</p> <p>For consistency throughout the league, boundaries defined by witches’ hats, metal uprights or the like will be regarded as out of play. Any ball rebounding from such an object will be declared DEAD. Batters and runners will advance, in accordance with the Official Rules of Baseball.</p>

9(e)	<p>Catch and Carry:</p> <p>To clarify the legality of catches made next to the Dead Ball Line (DBL), on open grounds the following interpretation is to be used:</p> <p>(i) For a catch to be legal, no part of the fielder's body can be grounded outside of the DBL. If part of the fielder's body over the DBL is in the air at the time of the catch, the catch is still legal.</p> <p>If the catch is taken in Live Ball Territory (LBT) and the fielder's momentum carries him over the DBL line, the catch is legal, the ball is dead, and any base runners will advance one (1) base. If a fielder's momentum carries him into DBT there can be no spectator interference. The fielder enters the DBT at their own risk.</p>
10. PROTECTIVE EQUIPMENT – HELMETS	
10(a)	All batters and runners MUST wear double-eared helmets with appropriate padding. Any player refusing to do so will be declared out. Any runner deliberately discarding or carrying a helmet will be declared out.
10(b)	The Umpire(s) has the right to inspect any helmet for safety, and not permit the use of any helmet which, in their opinion, is unsafe. Should a batter appear at the plate without a helmet, the Umpire shall call TIME and instruct the defaulting player to obtain a helmet before they will be allowed to take their time at bat.
10(c)	Base coaches in ALL MWBL games at all levels of baseball must wear a helmet at all times. Helmets can be skull caps. Junior players are to wear double-eared helmets if they are base coaching in any MWBL game. Junior players must have attained the age of fourteen (14) years old to base coach in a Seniors or Women's game.
11. PROTECTIVE EQUIPMENT – PROTECTORS AND MOUTHGUARDS	
11(a)	It is recommended that players wear appropriate protection whilst on the field during a game.
12. PROTECTIVE EQUIPMENT – CATCHERS	
12(a)	<p>ALL PERSONS WARMING UP PITCHERS MUST WEAR A MASK.</p> <p>All catchers MUST wear catchers helmets, masks or combined mask/helmet combination whenever they are catching in a warmup or game. This includes catchers, coaches, parents and other junior players who are catching any pitcher.</p>
12(b)	<p>Junior Catchers:</p> <p>It is compulsory for junior catchers to wear helmet, mask, throat guard, chest plate and leggings when catching.</p>
13. COLLISIONS AT THE PLATE	
13(a)	<p>A runner attempting to score may not deviate from their direct pathway to the plate in order to initiate contact with the Catcher (or other player covering home plate). If, in the judgment of the Umpire, a runner attempting to score initiates contact with the catcher (or other player covering home plate) in such a manner, the Umpire shall declare the runner out (even if the player covering home plate loses possession of the ball). In such circumstances, the Umpire shall call the ball dead and all other base runners shall return to the last base touched at the time of the collision.</p> <p>Please refer to OBR 7.13 for further details.</p>
14. PRE-MATCH WARM-UP	
14(a)	<p>Seniors and Women's:</p> <p>Twenty (20) minutes prior to the scheduled start time, the home team may use the diamond for a maximum of seven (7) minutes.</p> <p>Twelve (12) minutes prior to the scheduled start time, the away team may use the diamond for a maximum of seven (7) minutes.</p> <p>Team managers by mutual agreement can reverse order of team's pre-game warm up. Five (5) minutes prior to the scheduled start time, the diamond is to be vacated. Coaches from both teams are to meet with the Umpires at home plate to determine ground rules, match conditions and to exchange team line-ups.</p>
14(b)	<p>Juniors:</p> <p>Fifteen (15) minutes prior to the scheduled start time, the home team may use the diamond for a maximum of five (5) minutes.</p> <p>Ten (10) minutes prior to the scheduled start time, the away team may use the diamond for a maximum of five (5) minutes.</p> <p>Team managers by mutual agreement can reverse order of team's pre-game warm up. Five (5) minutes prior to the scheduled start time, the diamond is to be vacated. Coaches from both teams are to meet with the Umpires at home plate to determine ground rules, match conditions and to exchange team line-ups.</p>

15.	EXTENDED LINE-UP
15(a)	<p>Applicable to all Seniors and Women’s Grades except for A, A Res, B, B Res and C Grade</p> <p>An extended batting line-up (15 players maximum) may be used in applicable grades, and any team wishing to use the extended line-up must indicate their intention to do so prior to the start of the game, with the umpire(s) and opposition manager in attendance. It is not compulsory for both teams to use this rule.</p> <p>If a team has invoked the extended line up rule, players nominated on the extended line up can change fielding positions at any time during the game. There are no requirements for a player to play in the field at any time during the game.</p> <p>Bench players who have not participated in the game may take the place of an injured or removed player. If teams do not use the extended line-up, then they are bound by the traditional removal of players and bench players coming into the game.</p>
15(b)	<p>Line-Up Compression (Applicable to all Seniors and Women’s Grades except for A, A Res, B, B Res and C Grade)</p> <p>If a player on the extended batting line up does not take their turn at bat for any reason, then that batter is deemed to have been removed from the game and is then removed from the batting line up. The player can no longer participate in the game, and the line-up is compressed (no blanks) with all subsequent batters batting in order skipping the removed player.</p> <p>NOTE: A team can only compress an extended line-up back to nine (9) batters. Any additional players removed from the line-up (compression to seven (7) or eight (8) batters in the line-up) will result in a blank (and automatic out) in place of the removed players.</p>
16.	FIVE-MINUTE RULE
16(a)	<p>Applicable to all Seniors and Women’s MWBL games, except for A and B Grade Finals.</p> <p>If five minutes or less remains at the completion of even innings, the match shall end. If, at five minutes before the scheduled time of completion, the home team is at bat and is ahead, the match shall end.</p>
16(b)	<p>Applicable to all Early Games:</p> <p>The five-minute rule shall apply to all early games where two (2) or more Seniors or Women’s games are scheduled at the same ground on the same day with the following variation.</p> <p>If the five-minute rule applies a maximum of ten (10) minutes from the scheduled finish time will be allowed for the completion of the innings which commenced as per criteria listed above. The ten-minute time extension will apply to all situations and no time lost during the game will be added on to the extension of play. When the extra ten (10) minutes time has elapsed, umpires are to allow that batter to finish their time at bat or if during their at-bat, an out is made before ending the game.</p> <p>EXAMPLE: A match with a scheduled finish time of 2.15pm will have ten (10) minutes of allowable time added on should the five-minute rule be declared by the umpire. At 2.25pm (ten (10) minutes after the scheduled finish time, if there is no result (teams tied) or the innings has not been completed, the match will cease (end of game) and the scores revert back to the last even innings prior to the five-minute rule commencing (unless the home team has tied the game at 2.25pm).</p> <p>NOTE: Time is not to be added on to the length of games due to wet weather interruptions, unsafe ground conditions, etc. Games tied at the game time end (after equal innings) shall be recorded as a tied game.</p>
16(c)	<p>Late or Single Games:</p> <p>All late games and single games with a scheduled finish time shall be subject to the ‘Five-Minute Rule’ as listed in Match Condition 16(a). There shall be no time limit to complete any inning started before the five-minute rule is in effect.</p>

17. DETERMINATION OF RESULTS IN TIME GAMES

17(a) In regard to final scores in TIME games, various examples are given below.

Definition: An innings refers to when each team has had a time at bat. The basic principle to keep in mind is, When an UNEQUAL number of innings has been played, the score reverts back to the last completed number of equal innings except where:

- (i) The home team (batting second) is ahead.
- (ii) The home team (batting second), having scored an equal number to, or less runs than the away team (batting first) by the end of the last completed number of innings, has in the incomplete inning, scored sufficient runs to make the score a TIE.

In each of the following examples, "A" is the away team (batting first), and "B" the home team (batting second).

18. PITCHING RESTRICTIONS

18(a) Players are not permitted to pitch in two (2) games on the same day. This includes if a player pitches in a JUNIOR game, that player may not pitch in a SENIOR game on the same day. Coaches are responsible for overseeing this rule.

If this rule is violated the penalty to apply will be as follows: Forfeit of game in which violation occurred and/or a fine to apply. Further penalties may be determined by the MWBL Pennant Committee.

NOTE: Players are however permitted to pitch in one (1) Game on Saturday and then pitch in one (1) Game on Sunday. Junior Pitchers will be subject to the rest requirements of Match Condition 18(b).

If a pitcher's defensive outs are reached as a result of a 'pick off' or 'rundown' play, then the play will stand, and the pitcher is permitted to still pitch to the batter at bat even if they have not pitched to the batter before the 'pick off' or 'run down' play. <i>For Junior Games: If a pitcher's defensive outs are exceeded as a result of a 'Triple' or 'Double' play, then the play will stand, and the pitcher then should be replaced.</i></p> <p>(vi) For the purpose of this rule, players are to go by their League Age which is based on their birthday between September 1st and August 31st in any given year. 19.	BATTER'S TO REMAIN IN BATTER'S BOX
19(a)	<p>Batters shall be required to remain in the batter's box unless they make a request for 'time' and the umpire feels that the request is reasonable. Only then shall the umpire grant time out. If no runners are on base, the batter should not be granted time and not permitted to leave the Batter's box unless, in the opinion of the umpire, unusual circumstances exist which make the request a reasonable one.</p> <p>NOTE: For games umpired by a club umpire, the club umpire is to keep in mind what the intent of the rule is (to stop time wasting) and is not to be used in an unreasonable manner to create unnecessary issues during the game.</p> <p>Official Baseball Rules 6.02: The batter shall keep at least one foot in the batter's box throughout the batter's time at bat, unless one of the following exceptions applies, in which case the batter may leave the batter's box but not the dirt area surrounding home plate:</p> <ul style="list-style-type: none">(i) The batter swings at a pitch;(ii) The batter is forced out of the batter's box by a pitch;(iii) A member of either team requests and is granted time;(iv) A defensive player attempts a play on a runner at any base;(v) The batter feints a bunt;(vi) A wild pitch or passed ball occurs;(vii) The pitcher leaves the dirt area of the pitching mound after receiving the ball; or(viii) The catcher leaves the catcher's box to give defensive signals.
20.	DEFENSIVE VISITS
20(a)	<p>As per the Official Baseball Rules 5.10(l) and 5.10(m):</p> <ul style="list-style-type: none">(i) This rule limits the number of trips a manager or coach may make to any one pitcher in any one inning.(ii) A second trip to the same pitcher in the same inning will cause the pitcher's automatic removal from the mound but can remain in the game.(iii) The manager or coach is prohibited from making a second visit to the mound while the same batter is at bat; but,(iv) If a pinch hitter is substituted for the batter, the manager or coach may make a second visit to the mound but must remove the pitcher. A manager or coach is considered to have concluded a visit to the mound when having left the 18-foot circle surrounding the pitching rubber.(v) Mound visits without a pitching change shall be limited to four (4) per team, per nine (9) innings. For any extra-innings played, each team shall be entitled to one (1) additional non-pitching change mound visit per inning. <p>If the manager or coach goes to the catcher or infielder and that player then goes to the mound or the pitcher goes to that player at that player's position before there is an intervening play (a pitch or other play), that will be the same as the manager or coach going to the mound. Any attempt to evade or circumvent this rule by the manager or coach going to the catcher or an infielder and then that player going to the mound to confer with the pitcher shall constitute a trip to the mound.</p> <p>It will remain solely the umpire's judgement as to whether a visit to the mound by an on-field manager, coach or player to converse with the pitcher is considered an official pitching visit or as a visit 'in play' and not for coaching purposes.</p> <p>If the coach goes to the mound and removes a pitcher and then the manager goes to the mound to talk with the new pitcher, that will constitute one trip to that new pitcher in that inning. In the case where a manager has made a first trip to the mound and then returns the second time to the mound in the same inning with the same pitcher in the game and the same batter at bat after being warned by the umpire not to return to the mound, then the manager shall be removed from the game and the pitcher is required to pitch to the batter until the batter is retired or gets on base. After the batter is retired, or becomes a base runner, then this pitcher must be removed from the game. The manager should be notified that the pitcher will be removed from the game after pitching to one hitter so a substitute pitcher can be warmed up. The substitute pitcher will be allowed eight warm up pitches or more if, in the umpire's judgement, circumstances justify.</p>
21.	UNIFORMS
21(a)	<p>All players and coaches must wear approved uniform of the club. A, A Res, B and B Res Grades must have ALL players in approved uniform. All other Grades must have a minimum seven (7) players in approved uniform. Caps when worn MUST be approved club cap. Fine of \$10 for each player wearing an incorrect uniform.</p> <p>Advertising on Uniforms: Selective advertising is permissible on the back or sleeve of Seniors, Women's and Juniors uniforms. All such advertising must be approved by the MWBL. Clubs are cautioned that cigarette, liquor and hotel advertising will not be permitted.</p>

22. BLOOD AND CONCUSSION	
22(a)	<p>Blood Rule:</p> <ul style="list-style-type: none"> (i) An Umpire shall immediately direct a player to leave the playing field if the player is bleeding or has blood on any part of the uniform or body. The player's name and the time that the player is directed to leave the playing field shall be marked in the scorebook. (ii) When the umpire removes a player from the field under this rule, a reserve player can take his place and field and bat in his place until the removed player is able to return. If he cannot return before the expiry of one complete inning (six (6) outs from the removal) the reserve player becomes a normal substitute. The umpire's judgement as to whether the removed player is able to return will prevail. He would take into consideration the extent of the injury. (iii) In the case where there is no reserve player to take his place, another player who has previously been substituted can run and field in his place and can bat in the replacement batting position of the replaced player, as long as this at bat falls within the allotted six (6) outs from the removal of the injured player. Outside of these six (6) outs, the replacement player in this instance cannot bat. This would create a blank in the batting order and be an out in the inning. If no reserve is available then a team member is allowed to run only for the removed player as a proxy runner, but the runner must not be in the next four (4) batters in the batting order after the batter at the plate. <p>If ten (10) minutes after the player was directed to leave the field, the player has been unable to stop the bleeding and/or remove or cover the affected uniform area, the player must be replaced in the normal substitution manner.</p>
22(b)	<p>Concussion Rule:</p> <ul style="list-style-type: none"> (i) A player for any reason suspected of having sustained concussion during a game is to be removed immediately from the game in accordance with the Baseball Victoria Concussion Policy. The umpire is to be informed that the player is being removed due to concussion and the player's name and the time that the player is directed to leave the playing field shall be marked in the scorebook. (ii) A reserve player can take their place and field and bat in their place until the removed player has had the recommended concussion test and is able to return to play. If the player cannot return, then the replacement player then becomes a normal substitute and bats and fields in their place. <p>A replacement player can be either a reserve player that has not previously played in that game or in the case of no reserve player then another player that has previously been substituted in that game. Any replacement player that has played until the player removed has been cleared to be able return to play following a concussion test can then return to the bench and is now a legal reserve player and can re-enter the game as a normal substitute player.</p>
23. JEWELLERY	
23(a)	<p>Exposed jewellery such as wrist watches, bracelets and types of earrings, neck chains, or any other items judged as dangerous by the umpire may not be worn during the game. Medical bracelets or necklaces are not considered jewellery, but if worn must be taped to the body. Players must be asked to remove jewellery and if they fail to do so will be ejected from the game.</p>
24. FOOTWEAR	
24(a)	<p>Juniors - U11's, U13's and U15's:</p> <p>Players are permitted to wear moulded/plastic cleats (or football style boots), turf shoes or sneakers in any U11's, U13's or U15's games.</p> <p>NOTE: Metal cleats must NOT be worn by any junior player in games for these age groups. Umpires can inspect shoes at the start of the game. If a player is found to be wearing metal cleats during the game, then the player is to be asked to replace their metal cleats with appropriate footwear. Failure to adhere to this direction may result in an ejection from the game and the club issued a \$25 fine.</p>
24(b)	<p>Juniors - U17's, Seniors and Women's:</p> <p>Players are permitted to wear metal cleats, moulded/plastic cleats (or football style boots), turf shoes or sneakers in any U17's, Senior or Women's games.</p>

25. UMPIRES	
25(a)	<p>Where no league appointed umpire is present at the game, the Home Club shall appoint an “Plate Umpire” to call balls and strikes. The Visiting team should supply a “Base Umpire”. Club Umpires shall have the same authority as an MWBL appointed umpire. If the home team is not able to supply an “Plate Umpire” then the away side is permitted to. It is desirable that the “Plate Umpire” call from behind the catcher, however it is also practical to call balls and strikes from behind the pitching mound. It should be undertaken to ensure that only one person umpire the entire game. If this is not practical, then only one change shall be permitted.</p> <p>PENALTY: Failure by a Club to comply with any of the conditions concerning umpires may result in the offending Club being fined for each offence.</p>
25(b)	<p>Helmets:</p> <p>It is recommended that all umpires (including MWBL appointed and club umpires) when umpiring as a single umpire from behind the pitching mound wear a skull cap type helmet. Normal line umpires are not required to wear skull helmets.</p>
25(c)	<p>Change Rooms:</p> <p>Clubs are to provide appropriately clean and clear of equipment separate private area for umpires to be able to change into their gear and clothing without being exposed to the general public. If the change area is within the general pavilion area, then appropriate screening (temporary or permanent) are required to be provided. Failure to comply with this requirement many result in the club being brought before the MWBL Pennant Committee, fine applied and non-appointment of umpires to games at that ground.</p>
26. DISPUTES AND PROTESTS	
26(a)	<p>In the event of any dispute or protest (other than a judgement decision, which may not be disputed) the protest must be lodged at the time of the objection with the umpire who must be given the opportunity to consider the point raised by the manager. Should the Manager decide to continue the protest, the umpire shall be advised and before play continues the scorers must endorse both score books, ensuring the following details are marked:</p> <ul style="list-style-type: none"> (i) Position of runners on base; (ii) Time of day; (iii) Ball and strike count on batter; (iv) Score at time of protest; and (v) Number of outs <p>The Manager of the protesting team shall, at the conclusion of the match, advise the umpire whether the protest is to be proceeded with. It is then the responsibility of the protesting Manager to request the umpires to endorse upon the Match Report Card that a protest has been lodged.</p> <p>Notice of the protest must be lodged in writing, be delivered to the Administrator within forty-eight (48) hours of completion of the game and be accompanied by a one-hundred-dollar (\$100) fee, which shall be returned if the Pennant Committee does not consider the protest frivolous. The notice of protest shall include reference to the Official Baseball Rule being protested and full reasons why the protest is being entered.</p>
27. MATCH REPORTS	
27(a)	<p>For all games, both team managers are to report to the scorer’s area to check and sign the Match Report Sheet, which shall include:</p> <ul style="list-style-type: none"> (i) Box score of the game; (ii) Full names printed of all players of both teams who competed in the game; (iii) Junior pitch counts for junior players; and (iv) Best player votes also noted on the card for Seniors and Women’s games. <p>Both Home and Away teams are responsible for correct information submitted on the Match Report Sheet. Fines will be applied to both clubs for incorrect Match Report Sheet.</p> <p>NOTE: No team member may enter any remarks on the MATCH REPORT SHEET. Fine of \$25 for first offence. Second offence shall be as determined by the Pennant Committee.</p>

27(b)	<p>Emailing Of Scores:</p> <p>Scores must be emailed to the MWBL Administrator by 8.00pm the day of the game, or two (2) hours after the completion of the game (whichever is the latter). \$20 fine per score for no or late advice of match day score.</p> <p>Email: scores@mwbl.com.au</p> <ul style="list-style-type: none"> (i) HOME TEAMS are to email scores during the Home and Away Games (ii) APPOINTED UMPIRES are to email scores during the Finals Series. In the event of no MWBL appointed umpires, the HOME TEAM is to email scores during the Finals Series. <p>Match Report Sheet:</p> <p>Match Report Sheets can be sent to the MWBL Administrator by email within seventy-two (72) hours after the day of the game. Sheets sent via email or other electronic means MUST be legible to be accepted as received. \$10 fine / per sheet / per week for late sheets will be applied.</p> <p>NOTE: Rookie Ball Games are not played for match points. All details of the game shall be recorded on a Match Report Sheets as normal and forwarded to the MWBL Administrator. However, no ladders will be maintained, and finals not played.</p>
27(c)	<p>Scorers:</p> <ul style="list-style-type: none"> (i) Each club must supply a scorer for all MWBL games. Penalties subject to Schedule 1 of the By-Laws will apply to any club that fails to provide a scorer. (ii) Scorers shall be responsible for recording of match details and will sit together. (iii) Clubs shall provide suitable facility for scorers. (iv) The home team shall advise the League of the match details as directed. (v) Scorer's must follow the BASAP Scorer's Code of Conduct (Statement of Purpose and Rules – Part D) at all times, regardless of their level of accreditation. <p>Scorer's must notify the plate umpire when a Junior reaches ten (10) pitches remaining in their pitch count. The umpire will notify the Manager of the appropriate team. Scorer's must cross reference their pitch count with the opposition scorer on a regular basis to ensure they have the correct count. If one count is higher, the higher count shall be deemed correct.</p>
28. MANAGERS AND COACHES	
28(a)	<p>Seniors and Women's:</p> <ul style="list-style-type: none"> (i) Each team will nominate the team manager on the line-up card and make this clear to the umpire. (ii) During the match, the nominated team manager will be the only person to approach the umpires unless otherwise instructed. (iii) In the event of a ZERO TOLERANCE ejection as prescribed in Match Condition 4(c) / By-Law 29(h)(iv), the nominated manager will be ejected along with the player. The team must then nominate the manager to take over from this point. <p>The nominated manager (at the end of the match) is responsible for sighting and signing all match or report cards on behalf of their club. If a protest or dispute is referred to the MWBL, the person signing the Match Card as manager will be deemed by the MWBL as being that manager on the day and will represent as such at any subsequent hearing.</p>
28(b)	<p>Juniors:</p> <ul style="list-style-type: none"> (i) Two adult Managers or Coaches may be used on the base line at either first or third base. (ii) Players, Managers and Coaches must remain on the benches or in the prescribed area during a game. (iii) If a Manager or Coach goes onto the playing field (crosses a base line) more than once during the defensive half of an inning while the same player is pitching, such a Manager or Coach must make a pitching change. A third visit or any subsequent visit will also force the Manager or Coach to make a pitching change. This rule will be enforced by the Umpire. A Manager or Coach may, at any time, without penalty, go onto the ground for the sole purpose of giving aid to a sick or injured player. (iv) In U11's Rookie and U13's Minor, one (1) Adult defensive coach is permitted on the field during play to coach and encourage but must be situated behind second base and is not allowed on the infield. (v) Adult Manager or coaches in junior games are NOT to wear metal cleats. <p>In the event of a ZERO TOLERANCE ejection as prescribed in Match Condition 4(c) / By-Law 29(h)(iv), the nominated manager will be ejected along with the player. 29(a)	<p>Definition of ‘Non-National’ Player:</p> <ul style="list-style-type: none"> (i) A player will be deemed ‘Non-National’ if they: <ul style="list-style-type: none"> (a) Are not an Australian Citizen; or (b) Are not an Australian Permanent Resident. (ii) Clubs may request an exemption to the MWBL Pennant Committee for a ‘Non-National’ player to be granted ‘National’ status if the player meets one of the following: <ul style="list-style-type: none"> (a) Player is a ‘Junior’ and under eighteen (18) years of age; (b) Player is on a Student VISA studying in Australia at a University or TAFE (with their enrolment documents provided to MWBL for confirmation); (c) Player is in Australia for their employment on the appropriate Working VISA; or (d) Player has competed in at least six (6) rounds of the MWBL Competition in each of the previous two (2) MWBL seasons. <p>NOTE 1: The MWBL reserve the right to investigate any player suspected as a ‘Non-National’ that have not been declared by a club and request evidence to support citizenship, permanent residency or VISA status.</p> <p>NOTE 2: Approval by the MWBL Pennant Committee must be confirmed prior to the exemption taking effect and the MWBL Pennant Committee decision on Non-National Status will be final.</p> <p>The Melbourne Winter Baseball League accepts no responsibility for fulfilling of any obligations or requirements for entry of a ‘Non-National’ player into Australia, or any obligations or requirements noted within any contractual agreements between a Club and a ‘Non-National’ player. At the end of the season, all ‘Non-National’ players shall be subject to the clearance provisions set out in MWBL By-Law, should they choose to play for another club.</p>
29(b)	<p>Specific Rules for Non-National Players:</p> <ul style="list-style-type: none"> (i) A club may register as many ‘Non-National’ players as they choose, however, approval must be sought by the MWBL Pennant Committee prior to any ‘Non-National’ participating in the A, B or C Grade. (ii) There is no restriction on the number of ‘Non-National’ players that a club may register and play in any grade except for A, B, and C Grade. (iii) A club may only have one (1) ‘Non-National’ in their active line-up (in A, B or C Grade ‘Firsts’ team) at any time, including the designated hitter (DH). These players must be identified with a ‘NN’ designation on the match sheet. <p>NOTE 1: If a club plays more than one (1) ‘Non-National’ in their active line-up at any time in their A, B or C Grade team in any round, the penalty will be that the club will forfeit the game and the club imposed an ‘illegal player’ fine as per Schedule 1.</p>
29(c)	<p>Pitching Restrictions (Regular Season):</p> <ul style="list-style-type: none"> (i) For A, B and C Grade Games: <ul style="list-style-type: none"> (a) A club may only have any ‘Non-National’ pitch a maximum of eighteen (18) defensive outs across two (2) consecutive rounds. This restriction applies as a collective to each team and not individual players. (ii) For all other Grades: <ul style="list-style-type: none"> (a) Once a ‘Non-National’ has appeared in an A, B, or C Grade game, they will be ineligible to pitch in any other grade. All other players will be eligible to pitch without restriction. <p>NOTE 1: In the case of a final play being made where more than one out is recorded (therefore puts the pitcher over the eighteen (18) outs) this will not be considered as a breach.</p> <p>NOTE 2: Defensive outs must be recorded on the match sheet for Non-National Pitchers.</p> <p>NOTE 3: Should a Non National Player who has pitched in an A, B or C Grade game, pitch in another grade, they will be deemed an illegal player and subject to the resulting penalties.</p>

31(a)	<p>Game Length: All Grades – two (2) hours or nine (9) innings with the five-minute rule (Match Condition 16(a)) and Mercy Rule (Match Condition 31(f)) in effect. If time permits extra innings can be played in accordance with Match Condition 31(d).</p>
31(b)	<p>Game Times: Game Times will be published with the MWBL Fixtures. Should competing clubs wish to change a game start time, both clubs must submit, in writing, an application to the MWBL Administrator with the request to be reviewed by the MWBL Pennant Committee. Any requests must be made at least seven (7) days in advance of the game.</p> <p>Early Games and Single Games: Saturdays at 12:15pm, unless otherwise stated.</p> <p>Late Game: Saturdays at 2:40pm, unless otherwise stated or scheduled to start twenty-five (25) minutes after early game has finished but not before the scheduled start time unless agreed to by both managers and umpires. 31(c)	<p>Regulation Game: A legal minimum game shall consist of 5 innings (4.5 innings if home team ahead) in accordance with Official Baseball Rules OR not less than sixty-five (65) minutes play.</p> <p>Early Game: If there is any stoppage after 2:00pm due to bad weather, the game is to be stopped and scores will revert back to equal innings.</p> <p>Single and Late Games: The game will not start unless there is sixty-five (65) minutes playing time left, the five-minute rule may apply after sixty-five (65) minutes, but any stoppage during the sixty-five (65) minutes and the five-minute rule will not apply.</p> <p>Night Games: For night games, if there is any stoppage due to bad weather two (2) hours after scheduled starting time the game is to be stopped and scores will revert back to equal innings.</p>

In such cases, the manager should list 10 players on the team's lineup card, and this player should be named twice – once as the starting pitcher and once as the Designated Hitter. Thus, if the starting pitcher is replaced, that player can continue as the Designated Hitter (but can no longer pitch in the game), and if the Designated Hitter is replaced, that player can continue as the pitcher (but can no longer hit for himself).</p>
33(c)	<p>Designated Fielder for Pitcher: Applicable to all Senior Grades</p> <p>Position Players other than the catcher may be removed from the game in order to prepare to re-enter the game as the pitcher. A player removed from the game under this re-entry rule may only return as the pitcher and must do so during the current fielding inning in which they were removed, or they must begin the next fielding inning as the pitcher. Only one (1) player at any time can be removed from the game under this rule to warmup as a pitcher. Any player that re-enters the game must pitch to at least one (1) complete batter, unless;</p> <ul style="list-style-type: none">(i) The pitcher sustains an injury,(ii) The umpire-in-chief calls the game for any reason,(iii) An out occurs on the basepaths which would end the current inning. <p>After pitching to one (1) complete batter, the player is eligible to be moved to any other fielding position.</p> <p>Any player removed from the game under this rule will remain in the batting order and take their turn at bat as it occurs and would continue to accrue defensive outs.</p> <p>The designated fielder (the player who enters the game to allow a player to be removed from the game to prepare to pitch) will not be entered into the scorebook or match card (similar to the substitute runner for the pitcher / catcher). The substitute player must be a bench player eligible to enter the game. If the removed player does not re-enter the game in the current fielding innings or to start the following innings, the designated fielder will become a legal substitution for the removed player.</p> <p>The designated fielder will not have a turn at bat and will not accrue defensive outs while playing as the designated fielder for a player removed to prepare to pitch. A designated fielder entered under this rule, plays defence only in the position of the removed player whilst they prepare to pitch. Once the removed player re-enters the game, the designated fielder comes out of the game but remains eligible to re-enter the game as a normal substitute.</p> <p>The manager is to inform the umpire-in-chief (and the scorers) when they use the designated fielder for the pitcher. Failure to do so will result in the in the change becoming a legal substitution and the removed player will not be able to re-enter the game.</p>

33(d)	<p>Designated Pitcher: Applicable to A Res, B Res and C Res Only.</p> <ul style="list-style-type: none">(i) Each club can have up to two (2) players they nominate to use as a Designated Pitcher (DP). An umpire has the right to direct that a DP may not, if in contravention of this rule, participate in either game.(g) Penalty for contravention is forfeiture of the game in which such contravention took place. The Administrator shall keep eligibility of DPs and report any breaches to the Pennant Committee. <p>NOTE 2: This rule is not available for the finals.</p>
34.	RE-ENTRY RULE
34(a)	<ul style="list-style-type: none">(i) Applicable to A and B Grades:<p>For A and B Grade games, one (1) player who participated in the A Res or B Res game may also participate in the A or B Grade game from the start. All other players that participate in the A Res or B Res game cannot re-enter the A or B Grade game before the end of the second innings, except in the case of the Designated Pitcher from the Reserves game who must start in the A or B Grade game.</p>(ii) Applicable to A Res and B Res Grade:<p>For A Res and B Res games, one (1) player who has participated in a lower grade game at the same venue may also participate in the A Res or B Res game from the start of the game. All other players who participate in a lower grade game cannot re-enter the A Res or B Res game before the end of the second innings.</p> <p>In the event the A or B Grade game is played prior to the A Res or B Res game, all players from the A or B Grade game who started the game (or played prior to the end of the second innings) are ineligible to play in the A Res or B Res game, except for one (1) player who participated from the start. If away teams using their home ground - then they can use their usual dugout.</p>
78(b)	<p>Grounds:</p> <ul style="list-style-type: none"> (i) Bases, markers and line marking must be supplied by club on whose ground the match is played. (ii) On open grounds Home Run markers must be supplied and placed beyond the white line marked between the two foul lines. (iii) Refer to Match Condition 9(c) for Home run marshals in finals.
78(c)	<p>For Finals, all previous match conditions apply except for the following changes:</p> <p>All games with a scheduled finish time shall be subject to the 'Five Minute Rule'. If, at the completion of even innings, from the call of 'side out' there remains more than five minutes of time before the scheduled completion time, a further complete innings shall be played. Where wet or inclement weather or ground conditions prevent a game not achieving the Minimum Game Requirements (outlined below) or not achieving a result in the maximum playing time, the following procedures will apply:</p> <p>(a) All Juniors Grades: Five (5) innings or sixty-five (65) minutes</p> <p>(ii) If Game Tied:</p> <p>(a) If after application of the five-minute rule the game is tied at the time limit, the Umpire shall allow the teams to continue play in order to achieve a result. 78(e)	<p>Umpires and Match Sheets:</p> <p>Umpires to be appointed by the MWBL or if non available then competing clubs to supply in accordance with Match Condition 25(a). Match sheets are required for Finals Series games and to be sent to the MWBL Administrator no later than seventy-two (72) hours after the game by the umpires in accordance with Match Condition 27(b).</p> <p>If games are washed out, then match sheets are still required and umpires are requested to ensure that only names of players present at the game appear on the match sheet. For the Finals Games, Umpires are required to email the scores to the MWBL Administrator after the game by 8.00pm (or two (2) hours after the completion of the game, whichever is the latter) on the day of the game.</p>
